PRACTICE AND PROCEDURE ORDER NO. 2

Along with prior Practice and Procedure Orders entered in this Multidistrict Litigation, this Order shall govern the practice and procedure in those actions transferred to this Court by the Judicial Panel on Multidistrict Litigation pursuant to the Conditional Transfer Order entered on April 16, 2012, as well as any tag-along-actions thereafter transferred to this Court and any other actions, whether originally filed in this Court or transferred or removed to this Court, that are deemed to be related pursuant to Rule 50.3.1 of this Court's Rules for the Division of Business Among District Judges.
