## **ORDER**

A status conference and hearing was held today, at which various issues were addressed. Based on the discussions and rulings at the conference the following is ordered:

IT IS HEREBY ORDERED that any case specific <u>Daubert</u> motions and motions for summary judgment addressing the eight final trial pool cases shall be filed no later than **October 31, 2012**. Response briefs shall be filed no later than **December 15, 2012**. Reply briefs shall be filed no later than **January 7, 2013**.

IT IS FURTHER ORDERED that response briefs to the pending non-case specific

<u>Daubert</u> motions shall be filed no later than **October 16, 2012**. Reply briefs shall be filed no later than **November 6, 2012**.

**IT IS FURTHER ORDERED that** the first bellwether trial is set on **May 6, 2013**. The specific case to be tried will be identified at a future date.

**IT IS FURTHER ORDERED that** <u>Prather v. Organon</u>, 4:08CV558 RWS will be one of the first three cases tried in this District. At a future date, Defendants and Plaintiffs shall each select one of the remaining trial pool cases as the second and third case to proceed to trial. Defendants have agreed to waive Lexecon venue issues regarding these two cases.

**IT IS FURTHER ORDERED that** Plaintiffs' motion to compel Sammy Suissa PH.D. to produce documents [# 1222] is **DENIED**. No later than **September 3, 2012**, Plaintiffs may file a motion to compel based on Suissa's deposition as discussed in today's conference. In addition,

Plaintiffs may seek discovery of compensation Suissa received from Organon, or its successors, and their affiliates for any services provided to those entities.

IT IS FURTHER ORDERED that Defendants shall file a list of documents in their pending <u>Daubert</u> motions that they seek to remain sealed, and shall file a list of any documents in Plaintiffs' pending <u>Daubert</u> motions which Defendants seek to remain sealed, no later than **August 27, 2012**. Plaintiffs shall file a response to Defendants' lists no later than **August 28, 2012**.

IT IS FURTHER ORDERED that a status conference is set on October 4, 2012 at 10:30 a.m. The Court will address issues submitted by the parties in an agenda filed no later than October 2, 2012.

Counsel who wish to monitor the status conference are directed to call the conference toll free at <u>1-888-684-8852</u> from the United States (for callers outside the United States the caller paid international number is 215-446-0155).
