**JOINT MOTION TO EXTEND
DEADLINE FOR BELLWETHER PROTOCOL**

The parties to this multi-district litigation jointly request that the Court extend the deadline for the parties to submit a proposed bellwether Case Management Order presently set as January 6, 2014 pursuant to Paragraph 6 of Case Management Order No. 2 (dkt # 334), which provides: “On January 6, 2014 the Parties shall submit a proposed CMO addressing the bellwether process, which the parties agree will address case specific discovery.”

Inasmuch as generic discovery is only beginning, the parties are not yet in a position to propose a realistic schedule for case specific discovery and the selection of bellwether cases.

Accordingly, the parties jointly request that the Court extend the deadline for submission of a proposed bellwether Case Management Order indefinitely, subject to further discussion concerning the appropriate timing of the submission at the Status Conference scheduled for February 3, 2014.
