#### 2. UPDATE ON BELLWETHER DISCOVERY

"Core case-specific" discovery in the six (6) cases in the "Eligible Trial Pool" is nearly complete and the parties are on schedule to notify the Court by December 1, 2014 of their one (1) designated case from the Eligible Trial Pool as a candidate to be the first bellwether trial in this MDL pursuant CMO-15 as amended by CMO-15a and as revised by the Court's Order dated July 23, 2014 (Docket No. 161). Defendants Johnson & Johnson and McNeil anticipate a request for a brief delay in nominating bellwether cases due to the potential need to complete additional physician depositions and possible motion practice in advance of selection. Defendants will be prepared to report and discuss any revisions to CMO-15 that may be necessitated.
