**SCHEDULING ORDER:  
BELLWETHER TRIAL PROGRAM**

The Court, on August 20, 2014, entered its Bellwether Trial Program (the “Bellwether Program”) Scheduling Order. The Bellwether Program set March 9, 2015, as the trial date for the first Bellwether trial in this MDL. The Pretrial Conference for the trial is set for February 26, 2015. In anticipation of this trial and upon consideration of the scope of these proceedings, the Court sets the following scheduling order for pretrial motions and the consolidated pretrial order.

**Dispositive Motions**

January 9, 2015: Dispositive motions due.

January 27, 2015: Response to dispositive motions due

February 5, 2015: Reply briefs due. (Motions submitted to the Court)<sup>1</sup>

**Daubert Motions**<sup>2</sup>

January 15, 2015: *Daubert* Motions due.

January 30, 2015: Responses to *Daubert* motions due.

February 10, 2015: Reply briefs due.

**Motions in Limine**

January 30, 2015: Motions in limine due.

February 13, 2015: Responses to motions in limine due.

February 20, 2015: Reply briefs and Consolidated Pretrial Order due.


February 26, 2015: Pre-trial conference.

<sup>1</sup> After review of the complexity of any dispositive motion filed, the Court will determine if it is necessary to amend this schedule, and, if necessary, continue the trial to a later date.

<sup>2</sup> The Scheduling Order: Bellwether Trial Program entered by the Court on August 19, 2014, provides for expert discovery through February 20, 2015. To accommodate the filing and briefing of *Daubert* motions, if any, the parties agree that if an expert's deposition is taken on or after the January 15, 2015, filing due date, the party taking the deposition may supplement its *Daubert* motion, if one was filed, or may seek permission of the Court to file a *Daubert* motion outside of the January 15, 2015, filing deadline. *Daubert* motions are required to be fully briefed no later than fourteen calendar days before the February 26, 2015, Pre-trial conference.
