**CASE MANAGEMENT ORDER NO. 24  
(Plaintiffs' Leadership)**

In accordance with Case Management Order No. 4, and the Court having carefully reviewed the submissions of the Plaintiffs' Joint Application for Re-Appointment to the Plaintiffs' Steering Committee, it is hereby **ORDERED** that the attorneys designated herein shall serve as Plaintiffs' Co-Lead Counsel, Executive Committee, Steering Committee and Co-Liaison Counsel (collectively, the "Plaintiffs' Leadership") and shall continue to have the responsibilities described below.

## **B. Responsibilities of Plaintiffs’ Leadership**


