The Parties have reached agreement on a confidential Memorandum of Understanding (MOU) setting forth terms to resolve U.S. cases involving Mirena and allegations of secondary perforation personal injury and related claims. The cases covered by the MOU include:

- In Re: Mirena IUD Products Liability Litigation, 13-MD-2434 (S.D.N.Y.);
- In Re: Mirena IUD Products Liability Litigation, Multi-County Litigation Case No. 297 pending in Bergen County New Jersey Superior Court;
- All Mirena cases currently pending in the Circuit Court of the City of St. Louis, State of Missouri;
- All Mirena cases currently pending in California state court.

The resolution of these cases is subject to the completion of a final settlement agreement by the parties. Bayer does not admit any wrongdoing or liability as part of the agreement. Bayer said the resolution reflects a desire by the Company to avoid the distraction of continued litigation and focus on the needs of patients and prescriber.

Attorneys for Plaintiffs said they were pleased that their clients' claims will be resolved.
