CASE MANAGEMENT ORDER NO. 80 (Pretrial schedule for January 2018 bellwether trials)

On today's date, the Court held a case management conference by telephone regarding the January 2018 bellwether trials involving AbbVie, set for January 8, 2018, and Lilly, set for January 29, 2018. 1. January 8, 2018 AbbVie bellwether trial

Proposed preliminary jury instructions to be given at the outset of the trial—focusing only on the instructions regarding the claims and any defenses, as well as damages—and any proposed modifications to the jury questionnaire used in the *Konrad* case are to be filed by December 27, 2017. The final pretrial conference is set for January 4, 2018 at 1:30 p.m.

2. January 29, 2018 Lilly bellwether trial

Either *Garner v. Eli Lilly & Co.*, No. 1:15-cv-2045, or *DeBroka v. Eli Lilly & Co.*, No. 1:15-cv-9246, will be tried starting on January 29, 2018. Summary judgment and *Daubert* motions are to be filed by November 21, 2017; responses are to be filed by December 22, 2017, and replies are to be filed by January 5, 2018, all within the page limits previously ordered. The final pretrial order and motions *in limine* are to be filed by January 11, 2018. Responses to motions *in limine* are to be filed by January 18, 2018. Proposed preliminary jury instructions to be given at the outset of the trial—focusing only on the instructions regarding the claims and any defenses, as well as damages and any proposed modifications to the jury questionnaire used in the *Konrad* case are to be filed by January 18, 2018. The final pretrial conference is set for January 25, 2018 at 3:00 p.m.
