COMPLAINT FOR DAMAGES

DEMAND FOR JURY TRIAL

Plaintiff RUSSELL DENES (hereinafter referred to as “Plaintiff”), by and through counsel Aimee H. Wagstaff of ANDRUS WAGSTAFF, PC, alleges upon information and belief and complains of Defendants Syngenta AG (“SAG”) and Syngenta Crop Protection, LLC (“SCPLLC”) (together with their predecessors-in-interest, referred to collectively as the “Syngenta Defendants”); Chevron U.S.A. Inc. (together with its predecessors-in-interest, referred to collectively as the “Chevron Defendants”); and Does One through Sixty, and states:

STATEMENT OF THE CASE

1. Plaintiff RUSSELL DENES suffers from Parkinson’s disease caused by his exposure to the herbicide Paraquat.

1 laws of the State of Pennsylvania, with its headquarters and principal place of business in San
2 Ramon in Contra Costa County, California.

3 9. This Court has personal jurisdiction over each of the Defendants in this diversity
4 case because a state court of California would have such jurisdiction, in that:

5 a. Over a period of two (Chevron) to six (Syngenta) decades, each Defendant
6 and/or its predecessor(s), together with those with whom they were acting in concert,
7 manufactured Paraquat for use as an active ingredient in Paraquat products, distributed
8 Paraquat to formulators of Paraquat products, formulated Paraquat products, marketed
9 Paraquat products to the California agricultural community, and/or distributed Paraquat
10 products, intending that such products regularly would be, and knowing they regularly
11 were, sold and used in the State of California;

12 b. Plaintiff's claims against each Defendant arise out of these contacts between the
13 Defendant and/or its predecessor(s), together with those with whom they were acting in
14 concert, with the State of California; and

15 c. These contacts between each Defendant and/or its predecessors, together with
16 those with whom they were acting in concert, and the State of California, were so regular,
17 frequent, and sustained as to provide fair warning that it might be hauled into court there,
18 such that requiring it to defend this action in the State of California does not offend
19 traditional notions of fair play and substantial justice.

20 **INTRADISTRICT ASSIGNMENT**

21 10. This action arises from the actions of Defendants – and, in particular, the actions of
22 Defendant Chevron U.S.A., Inc. Defendant Chevron U.S.A., Inc. is a Pennsylvania corporation
23 with its principal place of business in San Ramon in Contra Costa County, California. Pursuant to
24 Local Rule 3-2(c), this claim may be assigned to either the San Francisco Division or the Oakland
25 Division.

26 **PARTIES**

27 11. The true names or capacities whether individual, corporate, governmental or
28 associate, of the defendants named herein as Doe are unknown to Plaintiff who therefore sues said

1 defendants by such fictitious names. Plaintiff prays leave to amend this Complaint to show their
2 true names and capacities and/or bases for liability when the same have been finally determined.

3 12. Plaintiff is informed and believes, and upon such information and belief alleges,
4 that each of the defendants designated herein as Doe is strictly, negligently, or otherwise legally
5 responsible in some manner for the events and happenings herein referred to, and negligently or
6 otherwise caused injury and damages proximately thereby to Plaintiff as is hereinafter alleged.

7 13. At all times herein mentioned each and every of the Defendants was the agent,
8 servant, employee, joint venturer, alter ego, successor-in-interest, and predecessor-in-interest of
9 each of the other, and each was acting within the course and scope of their agency, service, joint
10 venture, alter ego relationship, employment, and corporate interrelationship.

11 14. U.K. manufacturer Imperial Chemical Industries Ltd. a/k/a Imperial Chemical
12 Industries PLC ("ICI") first introduced Paraquat to world markets in or about 1962 under the
13 brand name GRAMOXONE®.

14 15. In or about 1971, ICI created or acquired a wholly owned U.S. subsidiary
15 organized under the laws of the State of Delaware, which was ultimately known as ICI Americas
16 Inc. ("ICI Americas").

17 16. Chevron Chemical Company was a corporation organized under the laws of the
18 State of Delaware.

19 17. Pursuant to distribution and licensing agreements with ICI and ICI Americas,
20 Chevron Chemical Company had exclusive rights to distribute and sell Paraquat in the United
21 States and did in fact manufacture, formulate, distribute, and sell Paraquat in the United States,
22 including in California for use in California, from approximately 1964 until approximately 1986.

23 18. Chevron U.S.A. Inc. is the successor-in-interest to Chevron Chemical Company.

24 19. At all relevant times, Chevron Chemical Company acted as the agent of Chevron
25 U.S.A. Inc. in selling and distributing Paraquat in the U.S. At all relevant times, Chevron
26 Chemical Company was acting within the scope of its agency in selling and distributing Paraquat.
27 Chevron U.S.A. Inc. is liable for the acts of its agent.
28

1 20. From approximately 1964 through approximately 1986, pursuant to distribution
2 and licensing agreements with Chevron Chemical Company, SAG's and/or SCPLLC's
3 predecessors-in-interest, ICI and ICI Americas, and Does One through Sixty manufactured some
4 or all of the Paraquat that Chevron Chemical Company distributed and sold in the United States,
5 including in California for use in California.

6 21. From approximately 1964 through approximately 1986, pursuant to distribution
7 and licensing agreements between and among them, ICI, ICI Americas, Chevron Chemical
8 Company, and Does One through Sixty acted in concert to register, manufacture, formulate, and
9 distribute and sell (through Chevron Chemical Company) Paraquat for use in the U.S., including
10 in California for use in California, and their respective successors-in-interest, SAG, SCPLLC, and
11 Chevron U.S.A. Inc., are jointly liable for the resulting injuries alleged herein.

12 22. After 1986, SCPLLC, Does One through Sixty, and/or their predecessors-in-
13 interest sold and distributed and continue to sell and distribute Paraquat in the United States,
14 including in California for use in California.

15 23. As a result of mergers and corporate restructuring, SAG is the successor-in-interest
16 to ICI.

17 24. As a result of mergers and corporate restructuring, SCPLLC is the successor-in-
18 interest to ICI Americas, Inc.

19 25. Thus, from approximately 1964 through the present, the Syngenta Defendants,
20 Does One through Sixty, or their predecessors-in-interest have manufactured, formulated,
21 distributed, and sold Paraquat for use in the U.S., including in California for use in California.

22
23 **PLAINTIFF'S EXPOSURE TO PARAQUAT**

24 26. At all relevant times, Plaintiff RUSSELL DENES worked in the agricultural
25 business—initially working for a certified herbicide applicator and later working as a certified
26 herbicide applicator—and in this capacity was exposed to Paraquat from the late 1970's until
27 approximately 2013: (1) when it was mixed, loaded, applied, and/or cleaned; (2) as a result of
28 spray drift (the movement of herbicide spray droplets from the target area to an area where

herbicide application was not intended, typically by wind); and/or (3) as a result of contact with sprayed plants.

27. At all relevant times, it was reasonably foreseeable that when Paraquat was used in the intended or a reasonably foreseeable manner, users of Paraquat and persons nearby would be exposed to it.

28. At all relevant times, it was reasonably foreseeable that Paraquat could enter the human body: (1) through absorption or penetration of the skin, mucous membranes, and other epithelial tissues (including tissues of the mouth, nose and nasal passages, trachea, and conducting airways, particularly where cuts, abrasions, rashes, sores, or other tissue damage were present); (2) through the olfactory bulb; (3) through respiration into the lungs; and (4) through ingestion into the digestive tract of small droplets swallowed after entering the mouth, nose, or conducting airways.

PARAQUAT CAUSES PARKINSON'S DISEASE

29. At all relevant times, it was reasonably foreseeable that Paraquat that entered a human body could ultimately enter the brain.

30. At all relevant times, it was reasonably foreseeable that Paraquat that entered a human body could induce the misfolding of the alpha synuclein protein.

31. Parkinson's disease is a progressive neurodegenerative disorder of the brain that affects primarily the motor system-the part of the central nervous system that controls movement.

32. The characteristic symptoms of Parkinson's disease are its "primary" motor symptoms: resting tremor (shaking movement when the muscles are relaxed), bradykinesia (slowness in voluntary movement and reflexes), rigidity (stiffness and resistance to passive movement), and postural instability (impaired balance).

33. Parkinson's disease's primary motor symptoms often result in "secondary" motor symptoms such as freezing of gait; shrinking handwriting; mask-like expression; slurred, monotonous, quiet voice; stooped posture; muscle spasms; impaired coordination; difficulty swallowing; and excess saliva and drooling caused by reduced swallowing movements.

1 34. Non-motor symptoms-such as loss of or altered sense of smell; constipation; low
2 blood pressure on rising to stand; sleep disturbances; and depression-are present in most cases of
3 Parkinson's disease, often for years before any of the primary motor symptoms appear.

4 35. There is currently no cure for Parkinson's disease; no treatment will stop or reverse
5 its progression; and the treatments most commonly prescribed for its motor symptoms tend to
6 become progressively less effective, and to increasingly cause unwelcome side effects, the longer
7 they are used.

8 36. One of the primary pathophysiological hallmarks of Parkinson's disease is the
9 selective degeneration and death of dopaminergic neurons (dopamine-producing nerve cells) in a
10 part of the brain called the substantia nigra pars compacta ("SNpc").

11 37. Dopamine is a neurotransmitter (a chemical messenger that transmits signals from
12 one neuron to another neuron, muscle cell, or gland cell) that is critical to the brain's control of
13 motor function (among other things).

14 38. The death of dopaminergic neurons in the SNpc decreases the production of
15 dopamine. Once dopaminergic neurons die, they are not replaced; when enough dopaminergic
16 neurons have died, dopamine production falls below the level the brain requires for proper control
17 of motor function, resulting in the motor symptoms of Parkinson's disease.

18 39. The presence of Lewy bodies (insoluble aggregates of a protein called alpha-
19 synuclein) in many of the remaining dopaminergic neurons in the SNpc is another of the primary
20 pathophysiological hallmarks of Parkinson's disease.

21 40. Dopaminergic neurons are particularly susceptible to oxidative stress, a disturbance
22 in the normal balance between oxidants present in cells and cells' antioxidant defenses.

23 41. Scientists who study Parkinson's disease generally agree that oxidative stress is a
24 major factor in-if not the precipitating cause of-the degeneration and death of dopaminergic
25 neurons in the SNpc and the accumulation of Lewy bodies in the remaining dopaminergic neurons
26 that are the primary pathophysiological hallmarks of the disease.

27 42. Paraquat is highly toxic to both plants and animals, creating oxidative stress that
28 causes or contributes to cause the degeneration and death of plant or animal cells.

1 43. Paraquat creates oxidative stress in the cells of plants and animals because of
2 “redox properties” that are inherent in its chemical composition and structure: it is a strong
3 oxidant, and it readily undergoes “redox cycling” in the presence of molecular oxygen, which is
4 plentiful in living cells.

5 44. The redox cycling of Paraquat in living cells interferes with cellular functions that
6 are necessary to sustain life—with photosynthesis in plant cells, and with cellular respiration in
7 animal cells. The redox cycling of Paraquat in living cells creates a “reactive oxygen species”
8 known as superoxide radical, an extremely reactive molecule that can initiate a cascading series of
9 chemical reactions that creates other reactive oxygen species that damage lipids, proteins, and
10 nucleic acids, molecules that are essential components of the structures and functions of living
11 cells. Because the redox cycling of Paraquat can repeat indefinitely in the conditions typically
12 present in living cells, a single molecule of Paraquat can trigger the production of countless
13 molecules of destructive superoxide radical.

14 45. Paraquat’s redox properties have been known to science since at least the 1930s.

15 46. It has been scientifically known since the 1960s that Paraquat (due to its redox
16 properties) is toxic to the cells of plants and animals. The same redox properties that make
17 Paraquat toxic to plant cells and other types of animal cells make it toxic to dopaminergic neurons
18 in humans—that is, Paraquat is a strong oxidant that interferes with the function of, damages, and
19 ultimately kills dopaminergic neurons in the human brain by creating oxidative stress through
20 redox cycling.

21 47. Paraquat is one of only a handful of toxins that scientists use to produce animal
22 models of Parkinson’s disease, i.e., use in a laboratory to artificially produce the symptoms of
23 Parkinson’s disease in animals.

24 48. Animal studies involving various routes of exposure have found that Paraquat
25 creates oxidative stress that results in the degeneration and death of dopaminergic neurons in the
26 SNpc, other pathophysiology consistent with that seen in human Parkinson’s disease, and motor
27 deficits and behavioral changes consistent with those commonly seen in human Parkinson’s
28 disease.

1 56. As a general rule, FIFRA requires registrants, the chemical companies registered to
2 sell the pesticides, to perform health and safety testing of pesticides. However, FIFRA does not
3 require the EPA itself to perform health and safety testing of pesticides, and the EPA generally
4 does not perform such testing.

5 57. The EPA registers (or re-registers) a pesticide if it is persuaded, based largely on
6 studies and data submitted by the registrant, that: (1) its composition is such as to warrant the
7 proposed claims for it, 7 U.S.C. § 136a(c)(5)(A); (2) its labeling and other material required to be
8 submitted comply with the requirements of FIFRA, 7 U.S.C. § 136a(c)(5)(B); (3) it will perform
9 its intended function without unreasonable adverse effects on the environment, 7 U.S.C. §
10 136a(c)(5)(C); and (4) when used in accordance with widespread and commonly recognized
11 practice it will not generally cause unreasonable adverse effects on the environment, 7 U.S.C. §
12 136a(c)(5)(D).

13 58. FIFRA defines “unreasonable adverse effects on the environment” as “any
14 unreasonable risk to man or the environment, taking into account the economic, social, and
15 environmental costs and benefits of the use of any pesticide.” 7 U.S.C. § 136(bb).

16 59. Under FIFRA, “[a]s long as no cancellation proceedings are in effect registration
17 of a pesticide shall be prima facie evidence that the pesticide, its labeling and packaging comply
18 with the registration provisions of [FIFRA].” 7 U.S.C. § 136a(f)(2). However, FIFRA further
19 provides that “[i]n no event shall registration of an article be construed as a defense for the
20 commission of any offense under [FIFRA].” 7 U.S.C. § 136a(f)(2).

21 60. The distribution or sale of a pesticide that is misbranded is an offense under
22 FIFRA, which provides in relevant part that “it shall be unlawful for any person in any State to
23 distribute or sell to any person ... any pesticide which is ... misbranded.” 7 U.S.C. § 136j(a)(1)(E).
24 A pesticide is misbranded under FIFRA if, among other things: (1) its labeling bears any
25 statement, design, or graphic representation relative thereto or to its ingredients which is false or
26 misleading in any particular, 7 U.S.C. § 136(q)(1)(A); (2) the labeling accompanying it does not
27 contain directions for use which are necessary for effecting the purpose for which the product is
28 intended and if complied with, together with any requirements imposed under section 136a(d) of

1 this title, are adequate to protect health and the environment, 7 U.S.C. § 136(q)(1)(F); or (3) the
 2 label does not contain a warning or caution statement which may be necessary and if complied
 3 with, together with any requirements imposed under section 136a(d) of this title, is adequate to
 4 protect health and the environment,” 7 U.S.C. § 136(q)(1)(G).

5 61. As a result, a pesticide may be misbranded despite an EPA determination that it
 6 met FIFRA’s registration criteria. In other words, notwithstanding its registration, a pesticide is
 7 misbranded if its label contains “false or misleading” statements, has inadequate instructions for
 8 use, or omits warnings or cautionary statements necessary to protect human health. Similarly, a
 9 pesticide may be found to cause unreasonable adverse effects on humans when used according to
 10 the approved label despite a determination by the EPA that it would not.

11 62. Plaintiff does not seek in this action to impose on Defendants any labeling or
 12 packaging requirement in addition to or different from those required under FIFRA. Any
 13 allegation in this Complaint that a Defendant breached a duty to provide adequate directions for
 14 the use of or warnings about Paraquat, breached a duty to provide adequate packaging for
 15 Paraquat, concealed, suppressed, or omitted to disclose any material fact about Paraquat, or
 16 engaged in any unfair or deceptive practice regarding Paraquat, is intended and should be
 17 construed to be consistent with that alleged breach, concealment, suppression, or omission, or
 18 unfair or deceptive practice having rendered the Paraquat “misbranded” under FIFRA. However,
 19 Plaintiff brings claims and seeks relief in this action only under state law, and does not bring any
 20 claims or seek any relief in this action under FIFRA.

21 **Acts of Syngenta Defendants**

22 63. SAG is a foreign corporation organized and existing under the laws of Switzerland,
 23 with its principal place of business in Basel, Switzerland. It is a successor by merger or
 24 continuation of business to its corporate predecessors, including but not limited to ICI.

25 64. SCPLLC is a limited liability company organized under the laws of the State of
 26 Delaware. It is a successor by merger or continuation of business to its corporate predecessors,
 27
 28

1 including but not limited to ICI Americas. SCPLLC is registered with the State of California,
2 Secretary of State to do business in the State of California.

3 65. SCPLLC or its corporate predecessors have sufficient minimum contacts with the
4 State of California and have purposefully availed themselves of the privileges of conducting
5 business in the State of California, in that they:

6 a. secured and maintained the registration of Paraquat products and other pesticides
7 with the CDPR to enable themselves and others to manufacture, distribute, sell, and use
8 these products in the State of California;

9 b. marketed, licensed, advertised, distributed, sold, and delivered Paraquat and
10 other pesticides to chemical companies, licensees, distributors, and dealers whom they
11 expected to distribute and sell Paraquat and other pesticides in or for use in the State of
12 California, including the Chevron Defendants and “Syngenta Retailers,” as well as to
13 applicators and farmers in the State of California;

14 c. employed or utilized sales representatives to market and sell Paraquat and other
15 pesticides in California;

16 d. maintained several locations throughout the State of California, including in the
17 towns of Sanger, Granite Bay and Roseville;

18 e. attended meetings of the CDPR’s Pesticide Registration and Evaluation
19 Committee relating to the registration of their pesticides, including Paraquat;

20 f. sponsored continuing education seminars for the CDPR at various locations in
21 the State of California, including the towns of Oxnard, Seal Beach, Rancho Santa Fe,
22 Somis, Orcutt, Woodland and Pala;

23 g. utilized California state courts to promote their pesticide business, including
24 filing an action against the CDPR and another pesticide manufacturer for allegedly using
25 Syngenta data to obtain approval of pesticides for others without its consent, *see Syngenta*
26 *Crop Prot., Inc. v. Helliker* (2006) 138 Cal.App.4th 1135; and filing an action against the
27 California EPA’s Office of Environmental Health Hazard Assessment challenging the
28 agency’s decision to list its pesticide atrazine as a chemical known to cause reproductive

1 toxicity under Proposition 65, *see Syngenta Crop Protection v. OEHHA* (Sacramento
2 Superior Court Case No. 34-2014-800001868); and

3 h. performed and funded the testing of pesticides in the State of California.

4 66. SCPLLC's contacts with the State of California are related to or gave rise to this
5 controversy.

6 67. SAG exercises an unusually high degree of control over SCPLLC, such that
7 SCPLLC is the agent or mere instrumentality of SAG. SCPLLC's contacts with California are thus
8 imputed to SAG for purposes of jurisdiction. *See City of Greenville, Ill. v. Syngenta Crop Prot.,*
9 *Inc.*, 830 F. Supp. 2d 550 (S.D. Ill. 2011).

10 11 **Acts of Chevron Defendants**

12 68. Chevron U.S.A., Inc. is a corporation organized under the laws of the State of
13 Pennsylvania, with its headquarters and principal place of business in San Ramon, California.

14 69. Does One through Sixty are corporate entities which are agents, joint venturers,
15 alter-egos, successors-in-interest, and predecessors-in-interest to Chevron U.S.A., Inc. Does One
16 through Sixty were each acting within the course and scope of their agency, joint venture, alter-
17 ego relationship, and corporate interrelationship. The exact nature, relation, and corporate
18 structure of Does One through Sixty have not yet been finally determined. Plaintiff reserves the
19 right to amend this complaint with corporate allegations when they are finally determined.

20 70. Jurisdiction is proper over Chevron U.S.A. Inc. because it is a California resident
21 and citizen, maintaining its principal place of business and headquarters in California.

22 23 **DEFENDANTS' TORTIOUS CONDUCT RESULTED IN RUSSELL DENES**

24 **DEVELOPING PARKINSON'S DISEASE**

25 71. Plaintiff RUSSELL DENES hereby refers to, incorporates, and re-alleges by this
26 reference as though set forth in full, each and every allegation hereinabove and makes them a part
27 of the following allegations.

28 72. Plaintiff RUSSELL DENES is a resident and citizen of Jackson County, Missouri.

1 73. Plaintiff RUSSELL DENES was exposed to Paraquat manufactured and sold by
2 Defendants.

3 74. Plaintiff RUSSELL DENES was in agricultural business until at least 2013.
4 Initially he was employed by a certified herbicide applicator, for whom he mixed Paraquat,
5 transferred it into application equipment, sprayed it, and cleaned the equipment. In or around
6 1983, he himself became a certified herbicide applicator, and continued mixing, transferring, and
7 spraying Paraquat, as well as cleaning the equipment.

8 75. During this time, Plaintiff RUSSELL DENES was in close contact to the Paraquat
9 that was designed, manufactured, and distributed by Defendants, and each of them. During that
10 time, Plaintiff RUSSELL DENES would also mix, load, spray, and/or clean Paraquat.

11 76. The Paraquat to which Plaintiff RUSSELL DENES was exposed entered his body
12 through absorption or penetration of the skin, mucous membranes, and other epithelial tissues
13 (including tissues of the mouth, nose and nasal passages, trachea, and conducting airways,
14 particularly where cuts, abrasions, rashes, sores, or other tissue damage are present); and/or 2)
15 through the olfactory bulb; and/or 3) through respiration into the lungs; and/or 4) through
16 ingestion into the digestive tract of small droplets swallowed after entering the mouth, nose, or
17 conducting airways. Once absorbed, the Paraquat entered his bloodstream, attacked his nervous
18 system, and was substantial factor in causing him to suffer Parkinson's disease.

19 77. Plaintiff RUSSELL DENES was diagnosed with Parkinson's disease in or about
20 August 2016.

21 78. Plaintiff RUSSELL DENES had no reason to suspect the diagnosis was connected
22 to his past Paraquat exposure.

23 79. Although Plaintiff RUSSELL DENES knew that the Paraquat to which he was
24 exposed was acutely toxic, he had no reason to suspect that chronic, low-dose exposure to
25 Paraquat could cause neurological diseases such as Parkinson's disease.

26 80. Plaintiff RUSSELL DENES was never told, either by a medical professional, by
27 media, or by the Defendants, that chronic, low-dose exposure to Paraquat could cause him to
28 suffer Parkinson's disease.

1 81. Plaintiff RUSSELL DENES first became aware of Paraquat's role in causing his
2 Parkinson's disease and the wrongful acts of the Defendants that caused or contributed to his
3 developing Parkinson's disease within a year of the filing date of this Complaint.

4 82. Plaintiff RUSSELL DENES did not discover this earlier because he had no reason
5 to suspect that his working with Paraquat could cause him to suffer Parkinson's disease.

6 83. Defendants' acts and omissions were a legal, proximate, and substantial factor in
7 causing Plaintiff RUSSELL DENES to suffer severe and permanent physical injuries, pain, mental
8 anguish, and disability, and will continue to do so for the remainder of his life.

9 84. By reason of the premises, it became necessary for Plaintiff RUSSELL DENES to
10 incur expenses from medical care and treatment, and related costs and expenses required in the
11 care and treatment of said injuries. Plaintiff RUSSELL DENES' damages in this respect are
12 presently unascertained as said services are still continuing.

13 85. By reason of the premises, it will be necessary for Plaintiff RUSSELL DENES to
14 incur future expenses for medical care and treatment, and related costs and expenses required for
15 future care and treatment. Plaintiff's damages in this respect are presently unascertained as said
16 services are still continuing. Plaintiff prays leave to insert elements of damages in this respect
17 when the same are finally determined.

18 86. By reason of the premises, Plaintiff RUSSELL DENES has been at times unable to
19 maintain regular employment, incurring special damages in a presently unascertained sum as said
20 loss is still continuing. Plaintiff prays leave to insert elements of damages with regards to past
21 wage loss, future wage loss, and lost earning capacity when the same are finally determined.

22 87. By reason of the premises, Plaintiff has suffered general (non-economic) damages
23 in a sum in excess of the jurisdictional minimum of this court.

24 88. By reason of the premises, Plaintiff has suffered special (economic) damages in a
25 sum in excess of the jurisdictional minimum of this court.

CAUSES OF ACTION

COUNT I - STRICT PRODUCTS LIABILITY DESIGN DEFECT

89. Plaintiff incorporates by reference each allegation set forth in preceding paragraphs as if fully stated herein.

90. Defendants are liable to Plaintiff under a products liability theory for marketing a defectively-designed product, as well as for failing to adequately warn of the risk of severe neurological injury caused by chronic, low-dose exposure to Paraquat.

91. At all relevant times, Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold Paraquat for use in the State of California.

92. At all relevant times and places, the Paraquat that Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold was used in the intended or a reasonably foreseeable manner.

93. Plaintiff RUSSELL DENES was exposed to Paraquat that Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold. As a result of that exposure, Paraquat entered Plaintiff RUSSELL DENES' body causing Plaintiff to develop Parkinson's disease.

94. The Paraquat that Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold did not perform as safely as an ordinary consumer would have expected it to perform when used in the intended or a reasonably foreseeable manner, in that:

a. as designed, manufactured, formulated and packaged Paraquat was likely to be inhaled, ingested, and absorbed into the bodies of persons who used it, who were nearby while it was being used, or who entered fields or orchards where it had been sprayed (or areas near where it had been sprayed); and

b. when inhaled, ingested, or absorbed into the body, it was likely to cause neurological damage that was both permanent and cumulative, and repeated low-dose exposures were likely to cause neurodegenerative disease, including Parkinson's disease.

1 95. Alternatively, Chevron U.S.A. Inc., the Syngenta Defendants, Does One through
2 Sixty, and their corporate predecessors' Paraquat products were defectively designed in that the
3 risk of danger inherent in the challenged design outweighed the benefits of such design,
4 considering, among other relevant factors, the gravity of the danger posed by the challenged
5 design, the likelihood that such danger would occur, the mechanical feasibility of a safer
6 alternative design, the financial cost of an improved design, and the adverse consequences to the
7 product and to the consumer that would result from an alternative design.

8 96. The design defect existed when the Paraquat left Chevron U.S.A. Inc., the Syngenta
9 Defendants, Does One through Sixty, and their corporate predecessors' possession and control.

10 WHEREFORE, Plaintiff respectfully requests that this Court enter judgment in Plaintiff's
11 favor for compensatory and punitive damages, together with interest, costs herein incurred,
12 attorneys' fees and all relief as this Court deems just and proper. Additionally, Plaintiff demands a
13 jury trial on all issues contained herein.

14
15 **COUNT II - STRICT PRODUCTS LIABILITY FAILURE TO WARN**

16 97. Defendants are also liable to Plaintiff under a products liability theory based on
17 their failure to adequately warn of the risks of Paraquat. Plaintiff incorporates by reference each
18 allegation set forth in preceding paragraphs as if fully stated herein.

19 98. When Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and
20 their corporate predecessors manufactured and sold the Paraquat to which Plaintiff was exposed, it
21 was known or knowable to Chevron U.S.A. Inc., the Syngenta Defendants, Does One through
22 Sixty, and their corporate predecessors in light of scientific knowledge that was generally accepted
23 in the scientific community that:

24 a. Paraquat was designed, manufactured, formulated, and packaged such that it was
25 likely to be inhaled, ingested, and absorbed into the bodies of persons who used it, who
26 were nearby while it was being used, or who entered fields or orchards where it had been
27 sprayed or areas near where it had been sprayed; and
28

1 b. when inhaled, ingested, or absorbed into the body, it was likely cause latent
2 neurological damage that was both permanent and cumulative, and that repeated, low-dose
3 exposures were likely to cause neurodegenerative disease, including Parkinson's disease.

4 99. The risk of contracting Parkinson's disease from chronic, low-dose exposure to
5 Paraquat presented a substantial danger to users of Paraquat when the product was used in a
6 reasonably foreseeable manner.

7 100. An ordinary consumer would not have recognized the potential risk of permanent,
8 irreversible neurological damage, including the risk of contracting Parkinson's disease, from
9 chronic, low-dose exposure to Paraquat.

10 101. Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their
11 corporate predecessors failed to warn of the potential risk of permanent, irreversible neurological
12 damage from chronic, low-dose exposure to Paraquat, and failed to provide adequate instructions
13 regarding avoidance of these risks.

14 102. As a direct and proximate result of Chevron U.S.A. Inc., the Syngenta Defendants,
15 Does One through Sixty, and their corporate predecessors' marketing a defective product, Plaintiff
16 suffered the injuries described in this Complaint.

17 WHEREFORE, Plaintiff respectfully requests that this Court enter judgment in Plaintiff's
18 favor for compensatory and punitive damages, together with interest, costs herein incurred,
19 attorneys' fees and all relief as this Court deems just and proper. Additionally, Plaintiff demands a
20 jury trial on all issues contained herein.

21
22 **COUNT III - NEGLIGENCE**

23 103. Plaintiff incorporates by reference each allegation set forth in preceding paragraphs as
24 if fully stated herein.

25 104. At all relevant times, Chevron U.S.A. Inc., the Syngenta Defendants, Does One
26 through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold
27 Paraquat for use in the State of California and throughout the United States.
28

1 105. Plaintiff RUSSELL DENES was exposed to Paraquat that Chevron U.S.A. Inc., the
2 Syngenta Defendants, Does One through Sixty, and their corporate predecessors manufactured and
3 sold.

4 106. The Paraquat to which Plaintiff was exposed was used in the intended or a reasonably
5 foreseeable manner.

6 107. At all times relevant to this claim, in researching, designing, manufacturing,
7 packaging, labeling, distributing, and selling Paraquat, Chevron U.S.A. Inc., the Syngenta
8 Defendants, Does One through Sixty, and their corporate predecessors owed a duty to exercise
9 ordinary care for the health and safety of the persons whom it was reasonably foreseeable could be
10 exposed to Paraquat, including Plaintiff RUSSELL DENES.

11 108. When Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and
12 their corporate predecessors designed, manufactured, packaged, labeled, distributed, and sold the
13 Paraquat to which Plaintiff was exposed, it was reasonably foreseeable that Paraquat:

14 a. was likely to be inhaled, ingested, and absorbed into the bodies of persons who
15 used it, who were nearby while it was being used, or who entered fields or orchards where
16 it had been sprayed or areas near where it had been sprayed; and

17 b. when inhaled, ingested, or absorbed into the bodies of persons who used it, who
18 were nearby while it was being used, or who entered fields or orchards where it has been
19 sprayed or areas near where it has been sprayed, it was likely to cause neurological damage
20 that was both permanent and cumulative, and repeated exposures were likely to cause
21 neurodegenerative disease, including Parkinson's disease.

22 109. In breach of the aforementioned duty to Plaintiff, Chevron U.S.A. Inc., the
23 Syngenta Defendants, Does One through Sixty, and their corporate predecessors negligently:

24 a. failed to design, manufacture, formulate, and package Paraquat to make it
25 unlikely to be inhaled, ingested, and absorbed into the bodies of persons who used it, who
26 were nearby while it was being used, or who entered fields or orchards where it had been
27 sprayed or areas near where it had been sprayed;

1 b. designed, manufactured, and formulated Paraquat such that it was likely to cause
2 neurological damage that was both permanent and cumulative, and repeated exposures
3 were likely to cause clinically significant neurodegenerative disease, including Parkinson's
4 disease;

5 c. failed to conduct adequate research and testing to determine the extent to which
6 exposure to Paraquat was likely to occur through inhalation, ingestion, and absorption into
7 the bodies of persons who used it, who were nearby while it was being used, or who
8 entered fields or orchards where it had been sprayed or areas near where it had been
9 sprayed;

10 d. failed to conduct adequate research and testing to determine the extent to which
11 Paraquat spray drift was likely to occur, including its propensity to drift, the distance it was
12 likely to drift, and the extent to which Paraquat spray droplets were likely to enter the
13 bodies of persons spraying it or other persons nearby during or after spraying;

14 e. failed to conduct adequate research and testing to determine the extent to which
15 Paraquat was likely to cause or contribute to cause latent neurological damage that was
16 both permanent and cumulative, and the extent to which repeated exposures were likely to
17 cause or contribute to cause clinically significant neurodegenerative disease, including
18 Parkinson's disease;

19 f. failed to direct that Paraquat be used in a manner that would have made it
20 unlikely to be inhaled, ingested, and absorbed into the bodies of persons who used it, who
21 were nearby while it was being used, or who entered fields or orchards where it had been
22 sprayed or areas near where it had been sprayed; and

23 g. failed to warn that Paraquat was likely to cause neurological damage that was
24 both permanent and cumulative, and repeated exposures were likely to cause clinically
25 significant neurodegenerative disease, including Parkinson's disease.

26 110. Chevron U.S.A. Inc., the Syngenta Defendants, Does One through Sixty, and their
27 corporate predecessors knew or should have known that users would not realize the dangers of
28

1 exposure to Paraquat and negligently failed to take reasonable steps to prevent the foreseeable risk
2 of harm from exposure to Paraquat.

3 111. As a direct and proximate result of Chevron U.S.A. Inc., the Syngenta Defendants,
4 Does One through Sixty, and their corporate predecessors' negligence, Plaintiff suffered the
5 injuries described in this Complaint.

6 112. Additionally, in the course of designing, manufacturing, packaging, labeling,
7 distributing, and selling Paraquat, Chevron U.S.A. Inc., the Syngenta Defendants, Does One
8 through Sixty, and their corporate predecessors violated laws, statutes, and regulations, including
9 but not limited to: sections of Food & Agriculture Code, Division 7, Chapter 2 (Pesticides) and
10 sections of Title 3, California Code of Regulations, Division 6 (Pesticides).

11 113. Plaintiff was a member of the class of persons that said laws, statutes, and
12 regulations were intended to protect.

13 114. The violations of said laws, statutes, and regulations by Chevron U.S.A. Inc., the
14 Syngenta Defendants, and Does One through Sixty were also substantial factors in causing
15 Plaintiff's injuries.

16 115. The injuries that resulted from the violations by Chevron U.S.A. Inc., the Syngenta
17 Defendants, and Does One through Sixty were the kind of occurrences the laws, statutes, and
18 regulations were designed to protect against.

19 WHEREFORE, Plaintiff respectfully requests that this Court enter judgment in Plaintiff's
20 favor for compensatory and punitive damages, together with interest, costs herein incurred,
21 attorneys' fees and all relief as this Court deems just and proper. Additionally, Plaintiff demands a
22 jury trial on all issues contained herein.

23
24 **COUNT IV - BREACH OF IMPLIED WARRANTY OF MERCHANTABILITY**

25 116. Plaintiff incorporates by reference each allegation set forth in preceding paragraphs
26 as if fully stated herein.

27 117. At all relevant times, Chevron U.S.A. Inc., the Syngenta Defendants, Does One
28 through Sixty, and their corporate predecessors engaged in the business of designing,

1 manufacturing, distributing, and selling Paraquat and other restricted-use pesticides and held
2 themselves out as having special knowledge or skill regarding Paraquat and other restricted-use
3 pesticides.

4 118. At all relevant times, Chevron U.S.A. Inc., the Syngenta Defendants, Does One
5 through Sixty, and their corporate predecessors designed, manufactured, distributed, and sold
6 Paraquat for use in the State of California.

7 119. Plaintiff was exposed to Paraquat that Chevron U.S.A. Inc., the Syngenta
8 Defendants, Does One through Sixty, and their corporate predecessors designed, manufactured,
9 distributed, and sold.

10 120. The Paraquat to which Plaintiff RUSSELL DENES was exposed was not fit for the
11 ordinary purposes for which it was used, and in particular:

12 a. it was designed, manufactured, formulated, and packaged such that it was likely
13 to be inhaled, ingested, and absorbed into the bodies of persons who used it, who were
14 nearby while it was being used, or who entered fields or orchards where it had been
15 sprayed or areas near where it had been sprayed; and

16 b. when inhaled, ingested, or absorbed into the bodies of persons who used it, who
17 were nearby while it was being used, or who entered fields or orchards where it had been
18 sprayed or areas near where it had been sprayed, it was likely to cause neurological
19 damage that was both permanent and cumulative, and repeated exposures were likely to
20 cause neurodegenerative disease, including Parkinson's disease.

21 121. As a direct and proximate result of Chevron U.S.A. Inc., the Syngenta Defendants,
22 Does One through Sixty, and their corporate predecessors' breach of implied warranty, Plaintiff
23 suffered the injuries herein described.

24 WHEREFORE, Plaintiff respectfully requests that this Court enter judgment in Plaintiff's
25 favor for compensatory and punitive damages, together with interest, costs herein incurred,
26 attorneys' fees and all relief as this Court deems just and proper. Additionally, Plaintiff demands a
27 jury trial on all issues contained herein.
28

COUNT V- PUNITIVE DAMAGES

122. Plaintiff incorporates by reference each allegation set forth in preceding paragraphs as if fully stated herein.

123. Defendants' conduct as alleged herein was done with oppression, fraud, and malice. Defendants were fully aware of the safety risks of Paraquat. Nonetheless, Defendants deliberately crafted their label, marketing, and promotion to mislead farmers and consumers.

124. This was not done by accident or through some justifiable negligence. Rather, Defendants knew that it could turn a profit by convincing the agricultural industry that Paraquat did not cause Parkinson's Disease, and that full disclosure of the true risks of Paraquat would limit the amount of money Defendants would make selling Paraquat in California. Defendants' objective was accomplished not only through its misleading labeling, but through a comprehensive scheme of selective fraudulent research and testing, misleading advertising, and deceptive omissions as more fully alleged throughout this pleading. Plaintiff was denied the right to make an informed decision about whether to purchase, use, or be exposed to an herbicide, knowing the full risks attendant to that use. Such conduct was done with conscious disregard of Plaintiff's rights.

125. There is no indication that Defendants will stop their deceptive and unlawful marketing practices unless they are punished and deterred. Accordingly, Plaintiff requests punitive damages against the Defendants for the harms caused to Plaintiff.

WHEREFORE, Plaintiff respectfully requests that this Court enter judgment in Plaintiff's favor for compensatory and punitive damages, together with interest, costs herein incurred, attorneys' fees and all relief as this Court deems just and proper. Additionally, Plaintiff demands a jury trial on all issues contained herein.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff requests this Court to enter judgment in Plaintiff's favor and against the Defendants for:

- a. actual or compensatory damages in such amount to be determined at trial and as provided by applicable law;

- b. exemplary and punitive damages sufficient to punish and deter the Defendants and others from future fraudulent practices;
- c. pre-judgment and post-judgment interest;
- d. costs including reasonable attorneys' fees, court costs, and other litigation expenses; and
- e. any other relief the Court may deem just and proper.

JURY TRIAL DEMAND

Plaintiff demands a trial by jury on all of the triable issues within this pleading.
