## <u>ORDER</u>

On June 8, 2021, a case management conference was held in this multidistrict litigation ("MDL"). This order memorializes the developments during the conference.

During this conference, Defendants C.R. Bard and Davol stated that their Motion to Exclude or Limit the Opinions and Testimony of Plaintiff's Expert David Kessler, M.D. in the *Johns* case (No. 18-1509, ECF No. 35) is moot because Plaintiff withdrew Dr. Kessler as an expert. Accordingly, the motion is now **DENIED AS MOOT**.

Proceedings were also rescheduled and briefing schedules were set as follows in *Johns*, No. 18-1509:

The First Final Pretrial Conference was rescheduled from July 14, 2021 to July 19, 2021.
 A modified case management order, Case Management Order ("CMO") No. 23-F, will be forthcoming.

• After the Court notifies the parties of the limiting instructions it intends to use at trial

regarding the Material Safety Data Sheets and the Food and Drug Administrations 510(k)

process, the parties will simultaneously submit briefing on the instructions within seven

days of receiving the limiting instructions.

• The parties will submit briefing on the proper scope of the opinion of Plaintiff's expert

replacing Dr. Kessler. Defendants will submit a brief not to exceed ten pages on or

before Friday, June 11, 2021 by 5:00 p.m. Plaintiff will submit his response brief not

to exceed ten pages on or before Tuesday, June 15, 2021 by 5:00 p.m.

• Plaintiff will file a motion to compel Third Party Red Oak to produce a privilege log.

Plaintiff will file his motion on or before June 11, 2021. Red Oak will file its response

within seven days of service of the motion.

In Milanesi, No. 18-1320, trial was set for January 10, 2022. A modified case

management order, CMO 29-A, will be forthcoming.

Finally, the Court selected Stinson, No. 18-1022, and Miller, No. 18-01443, as the

third and fourth bellwether trials in this MDL, respectively. A modified case management

order, CMO 25-A, will be forthcoming.
