**SUBMISSION OF CASES FOR RANDOM SELECTION AS INITIAL BELLWETHER
DISCOVERY CASES PURSUANT TO AMENDED CMO 7**

Pursuant to Section III(4)(b) of Amended CMO 7 [Dkt. 210], the Parties submit the following lists of cases as eligible for the random selection of four (4) Initial Bellwether Discovery Cases, which will be selected by the Parties using a computer-generated application. **List 1** is a list of cases in which Abbott is the sole defendant, from which the parties will use the computer-generated application to randomly select three (3) cases. **List 2** is a list of cases in which Mead Johnson is a defendant (either together with Abbott or as the sole defendant), from which the Parties will use the computer-generated application to randomly select one (1) case. *See* Amended CMO 7, § III(4)(b). For each List, the “Case Number” will be the number assigned to the case for the computer-generated application.
