**JOINT STIPULATION REGARDING EXTENSION OF THE
BELLWETHER SELECTION DEADLINES IN CASE MANAGEMENT ORDER NO. 3**

Pursuant to Section VII(G)¹ of Case Management Order No. 3 (ECF No. 69), the parties stipulate by agreement to a sixty (60)-day extension of the deadlines for the selection of Initial Bellwether Discovery Cases and associated deadlines, as set forth in Sections III-V of Case Management Order No. 3. Specifically, the PLC will make its selections on Friday, March 1, 2024. Defendant will make its selections on April 1, 2024. The parties seek this stipulation so as to allow Defendant additional time to secure medical records. Additionally, Defendant will identify to the PLC any purported deficiencies associated with outstanding Plaintiff Profile Forms. The parties further stipulate that the corresponding deadline to file Amended Complaints set forth in Section II is similarly extended to March 1, 2024.
