**JOINT STATUS REPORT  
FOR THE JUNE 27, 2024 CASE MANAGEMENT CONFERENCE**

The parties provide the following joint status report in advance of the Case Management Conference scheduled for June 27, 2024:

1. Following discussions with the Special Master pursuant to MDL Case Management Order No. 14, the parties have executed a confidential settlement agreement intended to resolve the personal injury cases in the MDL and related claims.

2. To facilitate the settlement, the parties believe the current stay of case management deadlines should be extended and any future deadlines set subject to the Court's entry of a case management order governing the efficient management of any cases that may remain or that may hereafter be filed in, transferred to, or removed to this Court.

3. The PSC intends to move for entry of an order providing a common benefit assessment to compensate and reimburse attorneys for appropriate services performed and expenses incurred for the administration and common benefit of this MDL. The PSC will be prepared to discuss such motion at the upcoming conference.

4. Subject to the Court's availability, the parties request that the next case management conference be scheduled for mid-September 2024. Counsel for the parties are amenable to appearing in-person if the Court prefers.
