JOINT STATUS REPORT FOR THE NOVEMBER 14, 2024 STATUS CONFERENCE

Co-Lead Counsel for Plaintiffs and counsel for Defendants provide this joint status report in advance of the status conference scheduled for November 14, 2024.

I. <u>Status of Pending Briefs/Motions/Orders:</u>

a. Plaintiffs' Motion for Dismissal Without Prejudice: On May 14, 2024, Plaintiffs filed a Motion to Dismiss Non-ovarian, Uterine or Endometrial Cancer Cases without Prejudice (see ECF No. 650). Defendants filed their joint Opposition to Plaintiffs' Motion on June 5, 2024 (see ECF No. 705). Plaintiffs filed their reply on June 20, 2024 (see ECF No. 724). Although the parties attempted to reach an agreement regarding the pending motion, following good faith meet and confers, the parties remain at an impasse. Defendants requested to be heard at the August 29, 2024, Case Management Conference on this pending motion. Pursuant to the Court's August 12, 2024 Minute Entry (see ECF No. 786), a separate hearing will be scheduled after the August 29, 2024 Case Management Conference for this motion to be heard, if needed.

Defendants report that the underlying Motion (*see ECF* No. 650) now applies to approximately 451 Plaintiffs who either were included in the original motion or have since requested to be added to the list (an increase from 411 Plaintiffs as reported in the October Joint Status Report). This number increases with each Court Call cycle, as Plaintiffs, who otherwise would have been included on the PFS delinquency or deficiency list for relief under CMO 9, ask to be removed from the Court Call List on the basis that they do not have a cancer diagnosis. In response to Plaintiffs who sought removal from the Court Call List, Defendants have agreed to remove these Plaintiffs from the May/June, August and November Court Call Lists pending the outcome of this Motion.

b. <u>L'Oréal S.A.'s Motion to Dismiss</u>: On September 16, 2024, L'Oréal S.A. filed a motion to dismiss (*see* ECF No. 838). As discussed at the October 10, 2024 Case Management Conference and memorialized in the Court's Minute Entry, the Court denied this motion without prejudice and ordered Plaintiffs to file an amended

Complaint against L'Oréal S.A. Plaintiffs filed a Master Complaint against L'Oréal S.A. on October 18, 2024 (*see* ECF No.899). L'Oréal S.A. was provided a new date by which to file an answer or otherwise file a responsive pleading of December 6, 2024. Per the Court's Minute Entry dated October 11, 2024 (ECF No. 883), by December 13, 2024, the parties are to submit a proposed briefing schedule with respect to L'Oréal S.A.'s anticipated motion to dismiss.

- c. <u>Proposed Pro Se Protocol</u>: The Court ordered the Parties to submit a proposed *pro se* protocol by October 31 (*see* ECF No. 917). The Parties submitted a proposed *pro se* protocol on October 31, 2024 for the Court's review. This protocol formalizes the process by which Motions to Withdraw as Counsel are addressed by this Court in this litigation and to allow Plaintiffs' Leadership and Defendants transparency into the notice and communication by which *pro se* Plaintiffs are made aware of their responsibilities, if they pursue their claim. The Parties will be prepared to answer any questions about the proposal at the November Case Management Conference.
- d. Proposed Amendment to CMO 10 and Dismissal Process: On October 22, 2024, the parties submitted a proposed Amendment to CMO 10 along with proposed template Notices of Dismissal in order to alleviate confusion surrounding pending motions to dismiss without prejudice for good cause. The parties will be prepared to discuss the proposed amendment and templates with the Court at the November 14th Case Management Conference, if necessary.
- e. Proposed Common Benefit Case Management Order: As requested by the Court's Minute Order dated December 11, 2023 (see ECF No. 326), the PLC filed their position statement on December 22, 2024. Keller Postman filed their objections on January 12, 2024 (see ECF No. 377). The PLC filed their response on January 24, 2024 (see ECF No. 411). On January 25, 2024, Keller Postman then filed a Motion to Strike the PLC's response due to the response being in excess of the page limitations (see ECF No. 412). On January 26, 2024, the PLC responded to this motion (see ECF No. 418) and the court denied Keller Postman's Motion to Strike (see ECF No. 419).

On August 22, 2024, the Court issued a Memorandum Opinion and Order granting the PLC's motion in part and denying in part (see ECF No. 811). The PLC was directed to submit a revised proposed Common Benefit Order incorporating this Order. On September 6, 2024, the PLC filed a motion for reconsideration (see ECF No. 831) and on October 11, 2024, the Court denied this motion and directing the PLC to submit a revised proposed Common Benefit Order by October 25, 2024 (see ECF No. 882). The PLC submitted their revised proposed Order to the Court's proposed order mailbox on October 25, 2024 and then an amended proposed Common Benefit Order on October 28, 2024. On October 30, 2024, an opposition to the proposed Common Benefit Order was filed by Singleton Schreiber (see ECF No. 927), a law firm who had a member on the Court's Leadership Development Sub-Committee. That attorney unilaterally terminated her membership on the

Leadership Development Sub-Committee via email to the PLC on October 29, 2024. The PLC intends to submit a response to the opposition submitted by Singleton Schreiber, and the PLC will be prepared to address these matters with the Court at the November 14th Case Management Conference, if necessary. Attorneys from Singleton Schreiber have informed the PLC that they will also be in attendance at the November 14th Case Management Conference to address their opposition if the Court wants to hear from either party.

- II. Report on Pending Motions to Amend Short Form Complaint: As discussed at the October 10, 2024 Case Management Conference and memorialized in the Minute Entry issued immediately thereafter, on October 18, 2024, Plaintiffs filed a Status Report identifying any pending motions to amend a Short Form Complaint (see ECF No. 898). At the time of filing the status report, there were no pending motions to amend as reported by MDL Centrality. As of the filing of this Joint Status Report only one case has a pending motion to amend a Short Form Complaint. That case is Bryant v. Revlon, Inc., et al (1:23-cv-07646). The motion to amend was filed on October 17, 2024 and awaits ruling.
- III. <u>Report on Bellwether Process</u>: Based upon the guidance from the Court at the October Case Management Conference, the parties will await a decision from the Court on the DWOP motions and at that time will commence their briefing on the best process and procedures to implement a bellwether process in this MDL.
- IV. <u>Deposition Protocol</u>: Defense counsel have sent the PLC a proposed deposition protocol and suggested vendor proposals. The PLC is reviewing the proposal prior to engaging in meet and confers to resolve potential differences. Defense counsel propose that the Court set a December 9, 2024 deadline for the submission of an agreed protocol, or to the extent an agreement cannot be reached, competing proposals and/or any statement that a deposition protocol is unnecessary.

V. <u>"Second-Wave" Defendants:</u>

- a. Status of Motions to Dismiss:
 - i. <u>Advanced Beauty, Inc.</u>: On July 12, 2024, Defendant Advanced Beauty, Inc. ("Advanced Beauty") filed its Motion to Dismiss (*see* ECF Nos. 752 and 753). Plaintiffs filed their response on August 30, 2024 (*see* ECF No. 823). Advanced Beauty's Reply was filed on September 30, 2024 (*see* ECF No. 862).
 - ii. <u>John Paul Mitchell</u>: On July 12, 2024, Defendant John Paul Mitchell filed its Motion to Dismiss (*see* ECF No. 750). Plaintiffs filed their response on August 30, 2024 (*see* ECF No. 822). John Paul Mitchell's Reply was filed on September 30, 2024 (*see* ECF No. 861).
 - iii. Wella Operations US LLC: On July 12, 2024, Defendant Wella Operations US LLC ("Wella") filed its Motion to Dismiss (*see* ECF Nos. 757-762).

- Plaintiffs filed their response on August 30, 2024 (see ECF No. 821). On October 9, 2024, Wella filed their Reply (see ECF No. 880).
- iv. Walgreen Co.: In accordance with the Court's Minute Order dated August 29, 2024, on October 14, 2024, Walgreen Co. ("Walgreens") filed a Motion to Dismiss the complaint filed by Plaintiff Evelyn L. Keating, as Personal Representative of the Estate of Elva Jean Keaton (see ECF No. 885-886, see also 1:24-cv-1467, ECF 24). Plaintiff's response brief is due on December 2, 2024 and Walgreens reply brief is due December 23, 2024.
- b. **Discovery Status**: Plaintiffs have served an initial set of interrogatories and requests for production of documents, as well as a set of interrogatories related to ESI on defendants Advanced Beauty Systems, John Paul Mitchell, Murrays Worldwide, RNA, Roux Laboratories, and Wella Operations US LLC.
 - At the October 10, 2024 Case Management Conference, the Court issued a temporary stay on discovery for the "second-wave defendants" until rulings are issued on the pending motions to dismiss, at which time Plaintiffs are to provide a status report as to the number of cases pending before each "second-wave defendant" and a hearing would be set to discuss proposals for discovery moving forward.
- c. **Bronner Brothers, Inc.**: On July 11, 2024, this Court gave Bronner Brothers, Inc. a deadline of July 25, 2024, to file a status report indicating an email address where Plaintiffs could effectuate service pursuant to CMO 8 (*see* ECF No. 769). Fourteen cases have been filed against Bronner Brothers, Inc. A master long form complaint was filed against Bronner Brothers, Inc. by leadership on May 28, 2024 (*see* ECF No. 677). To date, Bronner Brothers, Inc. has not appeared and has failed to file an answer.

As discussed at the October 11, 2024 Case Management Conference, Due to some uncertainty as to whether the registered agent was also Bronner Brothers, Inc.'s attorney, Bronner Brothers, Inc. was served in case number 1:23-cv-08511 on September 23, 2024. Their answer was due on October 14, 2024. To date they have not noticed their appearance or filed an answer or any other responsive pleading. Prior to the next hearing, Plaintiffs will be moving for default judgment.

VI. <u>Report on Plaintiff Fact Sheet Discovery Process</u>: Co-Lead Counsel for Plaintiffs and counsel for Defendants provide this joint update on the CMO 9 Plaintiff Fact Sheet ("PFS") intake and case dismissal protocol. CMO 9 sets out a negotiated and detailed process for Defendants to place Plaintiffs who are alleged to be non-compliant with their PFS discovery obligations on a Court Call List, subjecting these Plaintiff(s) to appropriate Court relief, including issuing an order to show cause, compelling production, or dismissal with or without prejudice.

The last Court Call Hearing was held on August 29, 2024 after which the Court issued various orders. (ECF Nos. 824, 837). Defendants are continuing to monitor Plaintiffs' compliance with the Court's orders and will continue to submit notices of noncompliance for the Court's consideration where appropriate, including unopposed notices wherever possible. The Court reserved its ruling on the Schedule 6 Plaintiffs from the August Court Call List pending the submission of a joint report on these plaintiffs. As ordered, the Parties submitted the Joint Status Report on the Schedule 6 Plaintiffs from the August Court Call List on September 18. (see ECF Nos. 843, 844).

The next CMO 9 Court Call Hearing is scheduled for 2:00 PM Central on November 13, 2024, which will be held in person for those who wish to appear in person and via Webex for those who wish to be heard but cannot attend in person. The Parties understand that audio also will be available for those who wish to listen but not be heard. The Parties will jointly submit the Court Call List of cases to be addressed at the hearing on November 8. Further details regarding alleged PFS delinquencies and deficiencies will be addressed with the Court Call List filing, rather than in this status report.

As outlined in CMO 9, PFS compliance process deadlines, including the timing for Defendants to provide a PFS Compliance Meet-and-Confer List of delinquent and/or deficient Plaintiffs to Plaintiffs' Leadership and when the Parties are required to schedule the PFS Compliance Meet and Confer, are determined based off of the date of the scheduled Court Call Hearing. There is currently no Court Call Hearing set after the November Court Call Hearing. The Parties will be prepared to discuss the schedule of ongoing Court Call Hearings at the November Case Management.

MDL Centrality Platform Update: The Parties continue to work with BrownGreer to VII. resolve technical and data issues necessary for the transition of the PFS deficiency review process data to the MDL Centrality platform. The Parties believe the PFS review process will be fully migrated to the MDL Centrality platform by the November Case Management Conference such that data for Plaintiffs on future Court Call Lists should be available for use post-November Court Call Lists. While the migration of the PFS deficiency process to MDL Centrality has begun, this integration was not complete for the November Court Call List and Hearing. This has not delayed Plaintiffs' ability to submit their PFSs and related materials, the Defendants' ability to identify deficiencies, or for many plaintiffs' counsel to cure alleged deficiencies. The system is dynamic in nature and the Parties intend to work cooperatively to ensure that functionality and reporting is available based on the Parties needs as litigation progresses. In addition, MDLC is working to develop a platform through which Plaintiffs will receive relevant notices from MRC as MRC collects third-party records using Plaintiffs' authorizations.

- VIII. <u>State Court Update</u>: Pursuant to this Court's Minute Order, ECF No. 114, the parties provide the following update on the state court and international court proceedings.
 - Cook County, Illinois Consolidated Actions: There are at least one hundred forty-five (145) cases filed in Cook County, and these are being consolidated before Judge Patrick T. Stanton on Motion Calendar C for motion practice and discovery. Motions to dismiss in four (4) bellwether cases were granted in part and denied in part, with leave to amend. Following the respective rulings in the bellwether motions to dismiss, consolidated plaintiffs filed an initial master complaint on September 25, 2024 and then an amended master complaint and short form complaint template on October 17, 2024, which defendants anticipate moving to dismiss. Motions to dismiss based on personal jurisdiction remain pending in the bellwether cases, and the Court has set a briefing schedule for certain of the jurisdictional motions. The next status before Judge Stanton is set for November 14, 2024.

Judge Kathy M. Flanagan, who is presiding over the trial calendar for the consolidated proceedings as head of the Cook County Law Division, has indicated that she will eventually be setting dates for joint trials of five plaintiffs at a time, and certain plaintiffs will likely be presenting their proposed trial cohorts for Judge Flanagan at the hearing on November 26, 2024. The parties appeared before Judge Flanagan for continued trial setting on October 29, 2024, to report on the amended and master pleadings. The Court determined that trial setting was not ripe at this time and that the Plaintiffs should give additional thought to creating cohorts that identify some commonality in the proposed cohorts.

Judge Flanagan set the matter for continued hearing on trial setting status to November 26, 2024. Judge Flanagan directed the consolidated plaintiffs to present their trial proposals.

Subject to Judge Stanton setting specific discovery deadlines, Judge Flanagan has directed defendants who are not challenging personal jurisdiction in every Cook County case in which they have been named and served (including those brought in some cases by non-resident plaintiffs against non-resident defendants) to produce all discovery materials from this MDL without waiving any current or future jurisdictional challenges. Plaintiffs seeking additional interrogatories or requests for production from those defendants that produce discovery from the MDL must file an appropriate motion with the motion judge seeking leave to issue such discovery.

• Georgia State Cases: There are at least sixty-two (62) cases pending in Chatham County, Georgia.² These cases have been consolidated for pretrial purposes before Judge Derek J. White. On June 21, 2024, the Georgia Court of Appeals issued its opinion in *Burroughs v. L'Oreal USA, Inc.*, Case No. STCV2201876, holding that plaintiff's strict liability claims were barred because plaintiff's first use of the alleged products occurred prior to the ten-year statute of repose period. On July 31, 2024, Ms. Burroughs filed a Petition for Writ of Certiorari to the Georgia Supreme Court. The consolidated matters are stayed pending resolution of this appeal.

There are also at least fifty-seven (57) cases pending in DeKalb County, Georgia.³ Briefing on motions to dismiss in each of these matters is ongoing. While these matters are not consolidated, they are now all being assigned to Judge Alvin T. Wong.

There are also at least seven (7) cases pending in Gwinnett County, Georgia.⁴

- New York State Cases: There are at least four (4) active cases in New York County, New York,⁵ all of which are currently or will be subject to motions to dismiss. Briefing is complete in one of the cases and a hearing scheduled for January 21, 2025.
- <u>Pennsylvania State Cases</u>: At least twenty-six (26) actions are pending in the Court of Common Pleas in Philadelphia County, Pennsylvania, which have been coordinated before Judge Denis Cohen.⁶ Briefing on pleading challenges in these cases is ongoing.

- Delaware State Cases: Defendants are aware of at least one (1) case filed in New Castle County, Delaware, which, upon proper service, will be subject to motions to dismiss.7
- Canadian Cases: Two (2) putative class actions are pending in Canada. No class certification motions have been filed in either case yet.
- IX. Request for Revised Deadlines for Certain Joint Status Reports: Due to the upcoming holidays, the Parties seek the Court's permission to submit the Joint Status Report on January 7, 2025 for the January 9, 2025 Case Management Conference, rather than on January 2, 2025, when it would currently be due.
