JOINT STATEMENT REGARDING STATUS OF RELATED CASES AND MEDIATION

Pursuant to the Court's Order of February 13, 2025 (ECF No. 30) and Case Management and Scheduling Order (ECF No. 32), Plaintiff Tirrell Allen ("Plaintiff") and Defendants Global Blood Therapeutics, Inc. and Pfizer Inc. ("Defendants") (collectively, "the Parties"), hereby submit this joint statement regarding (a) the status of any related cases in federal and state court and (b) a proposed mediator and mediation schedule.

A. Related Cases

The Parties are aware of the following related cases in federal and state courts:

- (1) Ricky Jolly, et al. v. Global Blood Therapeutics, Inc. and Pfizer Inc., No. 3:24-cv-09345-TLT (N.D. Cal. Thompson, J.) Status: Plaintiffs served the complaint on Defendants Global Blood Therapeutics, Inc. and Pfizer Inc. on January 6, 2025. Jolly Certificates of Service, ECF Nos. 7, 8. Defendants filed a motion to dismiss Plaintiffs' complaint on February 26, 2025, Jolly Mot. to Dismiss, ECF No. 21, and further briefing on the motion to dismiss is in progress.
- (2) Tolulope Afolabi v. Pfizer Inc., Global Blood Therapeutics, Inc., and Does 1 through 100, Case No. 24-CIV-08331 (Cal. Super. Ct. San Mateo Cnty.) Status: Plaintiff served the complaint on Defendants Pfizer Inc. and Global Blood Therapeutics, Inc. on December 31, 2024. Defendants filed a demurrer to Plaintiff's complaint on February 14, 2025 and further briefing on the demurrer is in progress. A hearing on Defendants' demurrer has been scheduled for January 12, 2026.
- (3) Raven Favor v. Global Blood Therapeutics, Inc., Case No. 25-CIV-01314 (Cal. Super. Ct. San Mateo Cnty.) Status: Plaintiff has not yet served the complaint. An initial case management conference is set for November 5, 2025.

By stipulation, Defendants' deadline to answer or otherwise respond to the complaint is March 20, 2025.
- (6) Trebor Hardiman v. Global Blood Therapeutics, Inc., Case No. CGC-24-619197 (Cal. Super. Ct. - San Francisco Cnty.) Status: Plaintiff served the complaint on Defendant Global Blood Therapeutics, Inc. on November 4, 2024. A joint stipulation for change of venue to the Superior Court of San Mateo County was filed on February 24, 2025. The venue transfer is pending.
